

## **Sweepstakes Official Rules:**

\* NO PURCHASE NECESSARY to enter or win. A purchase does not increase your chance of winning a prize. All submissions must be accompanied by a letter for a valid entry. ### Eligibility:

Sweepstakes is open only to legal residents of the continental United States and District of Columbia who are 18 years of age or older. Entrants must have a valid U.S. Social Security Number and/or a valid U.S. personal tax identification number. ### How to Enter:

Limit one entry per person. Multiple entries received from a person will void all such additional entries.

Entrant will receive confirmation entry has been submitted.
